Guidelines for providing assistance for the installation of Anti-hail Nets as per Budget Assurance 2018-19

Hailstorms in Himachal Pradesh are one of the major natural calamities resulting in substantial economic loss to the farmers by damaging the horticultural crops, particularly apple and vegetable crops, both qualitatively and quantitatively.

The scheme will primarily benefit small & marginal and women farmers of the state, helping them to substantially reduce qualitative and quantitative losses to their horticulture produce. The monetary gains are expected to be approximately Rs. 200 crore with significant contribution to the state GDP.

In order to mitigate the losses caused by hail storms & to meet out the demand from farmers of the State, the Honorable Chief Minister Himachal Pradesh has announced Rs. 10 crore for providing 80% subsidy to the farmers for the purchase of anti-hail nets with the target to bring about 30 lakh square meter under protection of anti-hail nets in the state during the year 2018-19.

Modalities for implementation of the scheme

- 1. Under this scheme, assistance will be provided to all categories of farmers of the State.
- 2. Only bonafide farmers of Himachal Pradesh shall be eligible for availing assistance under the scheme.
- 3. The maximum limit for availing assistance under this scheme will be restricted to 5000 sqr. mtr. area per beneficiary/family.
- 4. Any kind of practice which may lead to mis-utilization of the subsidy/government funds shall not be allowed. The beneficiary is also required to give an affidavit in this regard. If found so at any stage, beneficiary will be liable to face suitable legal action besides refund of the

whole subsidy amount with prevailing rate of interest. The amount disbursed to such beneficiary will be liable to be recovered as arrear of land revenue.

- 5. The interested farmer will have to apply on the format prescribed under the scheme alongwith requisite estimates and latest revenue records. The complete application will be submitted to the concerned Horticulture Extension Officer for further advise and necessary action.
- 6. The execution of any activity/component under this scheme shall be done by the beneficiary at his own level after getting due sanction/work order from the concerned DDH/SMS.
- 7. The subsidy claim should invariably comprise of the detailed inspection report of the concerned field officers of the Horticulture Department duly supported by the activity photographs. The concerned Subject Matter Specialist (Hort) will physically verify 100% of cases before submitting the cases to the DDH. The concerned DDH will physically inspect at least 25 % of the cases prior to the release of the subsidy.
- 8. The Department reserves the right to accept or reject the project proposals or restrict the approval of the project proposal subject to the availability of funds with the department. The decision of Director of Horticulture, H.P. shall be final in this regard.
- 9. The guidelines and cost norms which are already being followed under the Mission for Integrated Development of Horniculture (MIDH) will only be adhered to so as to maintain uniformity in the implementation of the scheme. The assistance will be provided to the farmers at par with the norms and guidelines of the MIDH detail of which are as follows:
