QUALITATIVE (QUALITY) GRADE STANDARDS FOR POCUREMENT OF PROCESSING GRADE MANGO FRUITS UNDER MIS – 2024

- 1. Mature fruits and unripe achari mango would be procured under the Scheme.
- 2. Fruits would be procured only in crates having capacity of about 20 Kgs., each.
- 3. The crates irrespective of the size would be returned to the fruit growers to the procurement agencies.
- 4. 2.5% more fruit in weight would be procured from the fruit growers for which extra fruit received by the agency would also be mentioned in the receipt, it means that in 20Kgs. crate, 20.500 Kgs. of fruits would be procured and receipt would be issued for 20 Kgs., & 0.5 Kgs extra fruit only, which do not include the weight of the crate.
- 5. Fruits would be procured only from those orchardists who possess Horticulture Card and no fruit would be procured from the contractors or other involved in the trade.
- 6. The procurement price for fruits of seedling mango varieties, grafted mango varieties and unripe achari mango has been approved for 2024 @ Rs.12.00 per Kg., Rs.12.00 per Kg., respectively.

7. All the expenses including the transportation costs and unloading of fruits at the collection Centre would be borne by the fruit growers and expenses incurred after the procurement of fruit would be borne by the procurement agency.

8. It would be highly desirable on the part of fruit growers that they would bring the fruits of different varieties of seedling as well as grafted mangoes in separate crates so that it becomes convenient for the procurement agencies, processors and consumers to sell/utilize the procured fruit in an optimal manner.

9. In no case the fruits of seedling, grafted mango varieties and unripe achari mango would be accepted in the same crate.

10. The fruits should be intact, sound, clean and free from foreign smell/taste.

11. The fruits with punctured skin, bird eaten would not be accepted.

12. Fruits having slight defects in shape, slightly hail damage and those having other minor defects like anthracnose spots with black tip and sooty blotch etc. would be accepted under the scheme.

13. Fruits having severe attack of fungal diseases / insect / pests or rotten fruits would not be accepted.

14. Wind fallen or shrivelled fruits would not be accepted under the scheme.

Sir,

I am directed to refer to your letter no. 4-33/2021-Udyan (M), dated 13-06-2024 on the subject cited above and to convey the approval of the Government for implementation of Market Intervention Scheme (MIS) for Processing Grade Mangoes in Himachal Pradesh during the year 2024 as under: -

- Under the scheme 250 M.T. fruit of seedling, 500 M.T. of grafted & 500 MT unripe Achari varieties of Mangoes will be procured @ ₹ 12.00 per Kg.
- ii. Procurement of fruits will be done by HPMC & HIMFED in Crates and these agencies will be allowed handling charges will be ₹ 1.30 per kg.
- iii. The Assumed Sale Realization has been fixed as ₹2500/- M.T. for fruits of seedling, unripe achari and ₹ 3500 per MT and grafted mango varieties respectively.
- iv. Under the scheme, 42 fruit collection centers will be opened. The HPMC and HIMFED will coordinate for setting up of procurement data for the last three to five years. These centers will be opened by the procurement agencies in case of need and will be manned and operated by HPMC and HIMFED with their own staff. The expenses on account of Management Cost will be paid only on actual basis i.e. salary of the outsourced staff, which will be exclusively hired for MIS Mango-2024.
- Under the scheme, 2.5 % extra fruits (by weight) will be procured from the farmers/orchardists keeping in view the evapotranspiration and respiration

- losses during the procurement and handling operations for which no receipt would be issued.
- vi. Under the scheme, fruits will be procured from those farmers/orchardists who possess Horticulture Cards and who own 10 bighas or less land under Mango cultivation. As such, no fruit will be procured from the contractors.

vii. This scheme will be implemented in the State from 01-07-2024 to 31-08-2024.

You are, therefore, requested to give wide publicity to the above mentioned decision of the Government through field offices/agencies and the media so that the fruit growers in the State could derive maximum benefit from the Scheme. The implementation report be sent to this Department immediately.
