Regarding Market Intervention Scheme for procurement of 'C' Grade apples in Himachal Pradesh for the year 2023-24.

Sir,

I am directed to refer to your office letter No. 1-2/2023-Udyan(M) dated 14.06.2023 and 16.06.2023 on the subject cited above and to convey approval of the Government for implementation of Market Intervention Scheme for procurement of 'C' Grade apples in Himachal Pradesh during the year 2023-24 as under:

- i. Market intervention scheme will be implemented for procurement of 1,43,778 M.T. apple for which procurement price will be Rs. 12 per Kg.
- ii. Overhead expenses will be Rs. 2.75 per kg.
- iii. Assumed sale Realization will be considered as Rs. 3.50 per kg.
- iv. Under the Scheme, 312 procurement centres will be opened as per demand of the fruit growers out of which, 210 collection centres will be opened and operated by HPMC and 102 by the HIMFED by their own staff/level for funds amounting to Rs. 276.48 lakh.
- v. Under the scheme, fruits would be procured in 35 Kg gunny bags. However, in view of evapo-transpiration and respiration losses, the net weight of fruit in such 35 Kgs bags would be 35.87 Kgs which do not include the weight of gunny bag. Nevertheless, receipt will be issued for 35 Kgs only. This year HPMC will procure fruits in crates within the catchment area of 50 kms from newly established Fruit Processing plant at Parala.

- vi. Only apple having diameter above 51mm will be procured/accepted under the scheme. Fruits having punctured skin or bird eaten/damaged would not be accepted. Fruits infested with insects/pests and fungal diseases including scab would not be accepted. Ethral sprayed fruits also would not be accepted. Immature as well as over mature fruits would not be accepted. Severely bruised fruits would not be accepted. Fruits having slight hail damage, russeting as well as misshapen fruits will be accepted.
- vii. Under MIS 2023, apple would be procured from the growers having horticulture card and not from contractors.
- viii. The MIS will be implemented in the State w.e.f. 20.07.2023 to 31.10.2023.
